- 4. If a large number of persons have indicated their desire to speak, the Chairman may reduce the time allowed for presentations in order to avoid unduly prolonging the meeting.
- 5. Presentations are limited to agenda items or other issues related to ECUA.
- 6. Comments of a personal nature concerning any individual or comments or actions which are disruptive will not be permitted.
