NOTICE OF PUBLIC HEARING

PROPOSED ESTABLISHMENT OF REVISED WATER AND WASTEWATER RATES AND CHARGES.

A public hearing will be held by the Emerald Coast Utilities Authority at 3:00 p.m. Thursday, September 27, 2018, at the Board meeting room of the Emerald Coast Utilities Authority, 9255 Sturdevant Street, Pensacola, Florida, for the purpose of hearing objections and comments to the proposed establishment of revised water and wastewater rates and charges, effective with the first complete billing cycle read on or after October 1, 2018, as delineated in Exhibit "A" to this notice.

Any person who desires to appeal any decision made by ECUA with respect to any matter considered at this hearing will need a record of the proceedings thereof. Since ECUA does not make verbatim records of its proceedings, such person may need to independently secure such a record which should include the testimony and evidence upon which the appeal is to be based.

Pursuant to the U.S. Americans with Disabilities Act, ECUA will make reasonable modifications for access to ECUA services, programs, and activities by any qualified individual with a disability.
