**ITEM 5 - RECONVENE SPECIAL BOARD MEETING**

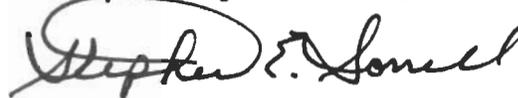
At approximately 1:40 p.m., Chairman McCorvey reconvened the special Board meeting.
