Sealed bids for Bid Number CC2014-01, 34<sup>th</sup> Street Lift Station #68 Replacement, will be received in the office of the Purchasing and Stores Manager, Emerald Coast Utilities Authority, located in the Emergency Operations & Support Addition, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL 32514, until 2:00 p.m., local time, Tuesday, February 11th, 2014, at which time bids submitted will be publicly opened and read aloud in the adjacent Room 2202, Finance Conference Room. Bids received after the closing time will be returned unopened. A non-mandatory pre-bid conference will be held at the Emerald Coast Utilities Authority Engineering Department Conference Room, located on the 2<sup>nd</sup> floor of the Customer Service Building at 9255 Sturdevant Street, Room 205, Pensacola, FL 32514, at 2:00 p.m., local time, on Tuesday, January 28th, 2014. The pre-bid is not mandatory, but attendance is strongly encouraged. The principal features of work will consist of the base bid involving the demolition and removal of the existing lift station building and wetwell and the construction of a new fiberglass wet well and associated piping and site work.
