Sealed bids for Bid Number CC2014-18, Broad Street Water Treatment Facility Replacement, will be received in the office of the Purchasing and Stores Manager, Emerald Coast Utilities Authority, located in the Emergency Operations & Support Addition, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL 32514, until 2:00 p.m., local time, Tuesday, June 10, 2014, at which time bids submitted will be publicly opened and read aloud in the adjacent Room 2202, Finance Conference Room. Bids received after 2:00 p.m., local time, June 10, 2014, will be returned unopened. A non-mandatory pre-bid conference will be held at the Emerald Coast Utilities Authority Engineering Department Conference Room, located on the 2nd floor of the Customer Service Building at 9255 Sturdevant Street, Room 205, Pensacola, FL 32514, at 10:00 a.m., local time, on Tuesday, May 20, 2014. Although the pre-bid is not mandatory, attendance is strongly encouraged. The principal features of work will consist of the demolition and disposal of the existing water treatment facility and related piping and site items; construction of the new Broad Street water treatment facility and process equipment; and the site work which includes stormwater drainage and pond, underground utility piping, and erosion control measures.
