Sealed bids for Bid Number CC2014-29, Escambia County CDBG Fire Hydrant Program – 2013 Program Year, will be received in the office of the Purchasing and Stores Manager, Emerald Coast Utilities Authority, located in the Emergency Operations & Support Addition, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL 32514, until 2:00 p.m., local time, Thursday, October 2, 2014, at which time bids submitted will be publicly opened and read aloud in the adjacent Room 2202, Finance Conference Room. Bids received after 2:00 p.m., local time, October 2, 2014, will be returned unopened. A pre-bid meeting will be held in the Emerald Coast Utilities Authority Engineering Department Conference Room, located on the 2nd floor of the Customer Service building at 9255 Sturdevant Street, Room 205, Pensacola, FL. 32514, at 10:00 am, local time on Tuesday September 23, 2014. This pre-bid in not mandatory, but attendance is strongly encouraged. The principal features of work will consist of installation of 3,200 L.F. of 6” water main, 20 L.F. of 4” water main, 80 L.F. of 2” water main, 5 fire hydrant assemblies, 30 L.F. of jack and bore with 12” steel casing, 30 short services and 24 long services. Split between base bid and additives: Will consist of the installation of 1,650 L.F. of 6” water main, 20 L.F. of 2” water main, 2 fire hydrant assemblies, 30 L.F. of jack and bore with 12” steel casing, 18 short services and 18 long services under the Base Bid. Additional work in the form of additive alternates will consist of the installation of 1,520 L.F. of 6” water main, 20 L.F. of 4” water main, 60 L.F. of 2” water main, 3 fire hydrant assemblies, 12 short services and 6 long services. by Addenda will be binding. Oral and other interpretations or clarifications will be without legal effect.

Addenda may be issued to clarify, correct, or change the Bidding Documents as deemed advisable by OWNER/ENGINEER.

The Bidding Document contains the provisions required for construction of the Work. Information obtained from an officer, agent, or employee of the OWNER or any other person shall not affect the risks or obligations assumed by the CONTRACTOR or relieve the CONTRACTOR from fulfilling any of the conditions of the Contract, unless properly documented by issuance of an Addendum.

The Emerald Coast Utilities Authority reserves the right to waive informalities in any bid; reject any or all proposals, in whole or in part; rebid a project, in whole or in part; and to accept a proposal that in its judgment is the lowest and best bid of a responsible bidder. In accepting a bid, ECUA may award a contract based only on the base bid, the base bid plus all alternates, or the base bid plus any alternates which ECUA selects – with all decisions being made based upon what ECUA believes to be the best interests of its ratepayers, in the reasonable exercise of its discretion. ECUA further reserves the right to increase or decrease quantities as may be required to meet the needs of ECUA at the unit price which was bid. The ECUA does not discriminate on the basis of race, color, national origin, sex, creed/religion, age, marital status, disability/handicapped status, veteran status, or any other legally protected status in employment or provision of service.
