Sealed bids for Bid Number CC2015-03, Perdido Bay Country Club Waterline Upgrades, will be received in the office of the Purchasing and Stores Manager, Emerald Coast Utilities Authority, located in the Emergency Operations & Support Addition, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL 32514, until 2:00 p.m., local time, Thursday, December 4, 2014, at which time bids submitted will be publicly opened and read aloud in the adjacent Room 2202, Finance Conference Room. Bids received after 2:00 p.m., local time, Thursday, December 4th, will be returned unopened. A pre-bid meeting will be held in the Emerald Coast Utilities Authority Engineering Department Conference Room, located on the second floor of the Customer Service Building at 9255 Sturdevant Street, Room 205, Pensacola, FL 32514, at 10:00 am local time, on Tuesday, November 25, 2014. The pre-bid is not mandatory, but attendance is strongly encouraged. The principal features of work will consist of the installation of approximately 10,000 LF of 8" water main, 200 LF of 6" water main, 100 LF of 4" water main, 12 Fire Hydrant Assemblies, 80 New Long Services, 62 New Short Services, fittings, valves, connections to existing water mains, and removal from service of existing water mains. The work will also include roadway and driveway pavement restoration, site restoration, and all other incidental work.
