Sealed bids for Bid Number CC2015-06, Downtown Water System Grid Improvements-Annual Contract, will be received in the office of the Purchasing and Stores Manager, Emerald Coast Utilities Authority, located in the Emergency Operations & Support Addition, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL 32514, until 2:00 p.m., local time, Tuesday, January 6, 2015, at which time bids submitted will be publicly opened and read aloud in the adjacent Room 2202, Finance Conference Room. Bids received after 2:00 p.m., local time, Tuesday, January 6, 2015 will be returned unopened. A Pre-bid Conference will be held in the ECUA Engineering Department Conference Room, located on the 2nd floor of the Customer Service Building at 9255 Sturdevant Street, Room 205, Pensacola, FL, 32514, at 10:00 a.m., local time, on Tuesday, December 16, 2014. The pre-bid is not mandatory, but attendance is strongly encouraged. The principal features of work will consist of the assistance with the insertion of approximately eleven (11) 12” valves, three (3) 10” valves, two (2) 8” valves, ten (10) 6” valves, as well as the complete installation of approximately five (5) 12” valves, three (3) 8” valves, twenty-seven (27) 6” valves, and the associated dewatering, roadway restoration, sidewalk restoration, and all other incidental work. Oral and other interpretations or clarifications will be without legal effect.

ECUA further reserves the right to increase or decrease quantities as may be required to meet the needs of ECUA at the unit price which was bid.
