Sealed bids for Bid Number CC2015-13, Pine Lake Estates Sewer Expansion, will be received in the office of the Purchasing and Stores Manager, Emerald Coast Utilities Authority, located in the Emergency Operations & Support Addition, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL 32514, until 2:00 p.m., local time, Tuesday, March 10, 2015, at which time bids submitted will be publicly opened and read aloud in the adjacent Room 2202, Finance Conference Room. Bids received after 2:00 p.m., local time, Tuesday, March 10, 2015 will be returned unopened. A Pre-bid Conference will be held in the ECUA Engineering Department Conference Room, located on the 2nd floor of the Customer Service Building at 9255 Sturdevant Street, Room 205, Pensacola, FL, 32514, at 10:00 a.m., local time, on Monday, February 23, 2015. The pre-bid is not mandatory, but attendance is strongly encouraged. The principal features of work will consist of the installation of approximately 1860 L.F. of 3" low pressure sewer force main, 745 L.F. of 2" low pressure sewer force main, 40 L.F. of 6" steel casing, 15 short low pressure sewer services, and 11 long low pressure sewer services under the base bid. Questions received less than seven (7) calendar days prior to the date for the opening of bids will not be answered. Only questions answered by addenda will be binding. Oral and other interpretations or clarifications will be without legal effect.

The Emerald Coast Utilities Authority reserves the right to waive informalities in any bid; reject any or all proposals, in whole or in part; rebid a project, in whole or in part; and to accept a proposal that in its judgment is the lowest and best bid of a responsible bidder. In accepting a bid, ECUA may award a contract based only on the base bid, the base bid plus all alternates, or the base bid plus any alternates which ECUA selects – with all decisions being made based upon what ECUA believes to be the best interests of its ratepayers, in the reasonable exercise of its discretion. ECUA further reserves the right to increase or decrease quantities as may be required to meet the needs of ECUA at the unit price which was bid.
