A MANDATORY PRE-BID CONFERENCE AND SITE REVIEW will be held at the Emerald Coast Utilities Authority Central Water Reclamation Facility, located at 2980 Old Chemstrand Road, Cantonment, Florida 32533, on Wednesday, March 6, 2013 at 10:00 am local time. Bids received from entities not represented at the pre-bid conference shall not be opened. In essence, the list of attendees at the pre-bid conference will constitute the approved bidder's list. The principal features of the work will consist of installation of owner furnished septage treatment and receiving equipment. The work will include construction of all structural, mechanical, and electrical components that are associated with this system.
