Sealed bids for Bid Number CC2013-13, Gardenia Circle Sewer Expansion, will be received in the office of the Purchasing and Stores Manager, Emerald Coast Utilities Authority, located in the Emergency Operations & Support Addition, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL 32514, until 2:00 p.m., local time, Tuesday, May 21, 2013, at which time bids submitted will be publicly opened and read aloud in the adjacent Room 2202, Finance Conference Room. Bids received after the closing time will be returned unopened. A pre-bid conference will be held at the Emerald Coast Utilities Authority Engineering Department Conference Room, located on the 2nd floor of the Customer Service Building at 9255 Sturdevant Street, Pensacola, FL 32514, at 9:00 a.m., local time, on Tuesday, April 30, 2013. The principal features of work will consist of the installation of approximately 4,700 LF of 8" gravity sewer, 31 manholes with 90 service laterals, 290 LF of 16" jack and bore, 360 SY of asphalt patch and 750 SY of asphalt overlay. The project includes driveway repair and right-of-way restoration (sodding). The project also includes as an Additive Alternate, the installation of 650 LF of C-900 watermain and the renewal of 67 water services. Plans and specifications may be examined at the:
