Sealed bids for Bid Number CC2013-18, Pensacola Beach Water Main Upgrades (Project 2), will be received in the office of the Purchasing and Stores Manager, Emerald Coast Utilities Authority, located in the Emergency Operations & Support Addition, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL 32514, until 2:00 p.m., local time, Thursday, September 5th, 2013, at which time bids submitted will be publicly opened and read aloud in the adjacent Room 2202, Finance Conference Room. Bids received after the closing time will be returned unopened. A pre-bid conference will be held at the Emerald Coast Utilities Authority Engineering Department Conference Room, located on the 2nd floor of the Customer Service Building at 9255 Sturdevant Street, Room 205, Pensacola, FL 32514, at 9:00 a.m., local time, on Tuesday, August 20, 2013. The pre-bid is not mandatory, but attendance is strongly encouraged. The principal features of work will consist of the installation of approximately 10,500 LF of 6" PVC waterline with 160 water service transfers, 150 SY of asphalt roadway patch, and 1,200 SY of driveway repair. The project also includes right-of-way restoration as well as multiple connections to existing cast iron water lines. Plans and specifications may be examined at the:
