Sealed bids for Bid Number CC2013-19, Barcelona Water Tank 2013, will be received in the office of the Purchasing and Stores Manager, Emerald Coast Utilities Authority, located in the Emergency Operations & Support Addition, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL 32514, until 2:00 p.m., local time, Thursday, September 5th, 2013, at which time bids submitted will be publicly opened and read aloud in the adjacent Room 2202, Finance Conference Room. Bids received after the closing time will be returned unopened. A pre-bid conference will be held at the Emerald Coast Utilities Authority Engineering Department Conference Room, located on the 2nd floor of the Customer Service Building at 9255 Sturdevant Street, Room 205, Pensacola, FL 32514, at 2:00 p.m., local time, on Tuesday, August 20, 2013. The pre-bid is not mandatory, but attendance is strongly encouraged. The principal features of work will consist of the complete cleaning and repainting of the “Barcelona Tank” on the interior surfaces, and the spot cleaning and top-coating of the exterior surfaces with containment. Additional work items include: repair of concrete and grout; furnishing and installation of balcony extension at access, balcony railing, shell and roof ladder, ladder safe-climbing devices, antenna cable brackets, davit for riser manhole cover, and cathodic protection system; modification of ladder vandal deterrent and interior ladder rungs to be slip-resistant; patching of openings in the balcony; including other miscellaneous repairs and incidental items such as coordination with the OWNER, two year anniversary evaluation, disposal of debris, site restoration, etc..
