A MANDATORY PRE-BID CONFERENCE AND SITE VISIT will be held in the offices of Baskerville-Donovan, Inc., located at 449 West Main Street, Pensacola, FL 32502, at 10:00 am local time, on Thursday, October 31, 2013. The site visit will immediately follow at the existing tank site at 425 Pensacola Beach Boulevard. Bids received from entities not represented at the pre-bid conference shall not be opened. In essence, the list of attendees at the pre-bid conference will constitute the acceptable bidder's list. The principal features of work will consist of the application of the coating to a 3.0 MG concrete ground storage tank. The work will also include removal and reinstallation of the existing lightning protection system and site cleanup.
