The principal features of the work will generally consist of the cleaning and television inspection of sanitary sewer mains on an "as-needed" basis for the Emerald Coast Utilities Authority. Consequently, there are not pre-determined quantities on which to base a fixed price. The maximum value of the Contract per year is expected to be \$250,000.
