Sealed bids for Bid Number CC2012-10, Sanitary Sewer Manhole Rehabilitation Annual Contract, will be received from pre-qualified bidders only in the office of the Purchasing And Stores Manager, Emerald Coast Utilities Authority, 9255 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL, 32514, until 2:00 p.m., local time, Tuesday, July 24, 2012, at which time bids submitted will be publicly opened and read in Room 215, Purchasing Section, 2<sup>nd</sup> floor of the ECUA Customer Service Building. Bids received after the closing time will be returned unopened. A pre-bid meeting will be held at 9:00 a.m. local time, Tuesday, July 10, 2012 in the ECUA Engineering Department, 9300 Sturdevant Street, Ellyson Industrial Park, Pensacola, FL, 32514. The principal features of the work will generally consist of the rehabilitation of sanitary sewer manholes using cementitious and epoxy/urethane products or Engineer-approved equals on an "as-needed" basis. Consequently, there are not pre-determined quantities on which to base a fixed price. The maximum value of the Contact per year is expected to be \$250,000.
